

**UNION OF NATIONAL DEFENCE EMPLOYEES  
LOCAL FINANCIAL STATEMENTS  
INSTRUCTIONS AND GUIDELINES**

The next set of audited financial statements due from locals must cover the period from October 1<sup>st</sup>, 2022 to September 30<sup>th</sup>, 2023. These must be received at the UNDE National Office, after approval at the local level, no later than December 31<sup>st</sup>, 2023, in order to receive the January rebate. Rebates will be held until Financial Statements have been received.

Attached for reference and use of each UNDE Local is a sample format for the preparation of Annual Audited Financial Statements. The set includes an Audit Report, Balance Sheet and an Income Statement.

The Audit Report shows the period covered by the financial statements and provides an opinion of the fairness and accuracy of the information contained herein. Should the auditors believe the statements are incorrect or incomplete, the reasons(s) why should be explained. The report should be signed by the auditors and dated, etc.

The Balance Sheet shows the local's assets, liabilities, and the members' equity as of September 30<sup>th</sup> of each year.  $\text{Total Assets} = \text{Total Liabilities} + \text{Members' Equity}$ . The items shown on the sample Balance Sheet are examples. Each local should show the value of each of its particular assets and liabilities as of September 30<sup>th</sup>.

The Income Statement shows the income received by the local and the expenses incurred during the period of October 1<sup>st</sup> to September 30<sup>th</sup> each year. Once again, the list of types of income and expenses are examples and each local should use these as a guide but should show breakdowns of income and expenses for their own local.  $\text{Total Income} - \text{Total Expenses} = \text{Net Income}$  (or net loss if result is negative).

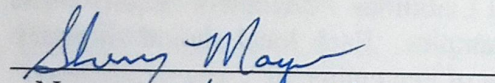
